Tax Information

Please make checks payable to IVMA or use credit card and return in enclosed envelope. Payments and dues paid to the IVMA are not deductible for federal tax purposes as charitable contributions. They may be deductible as any ordinary and necessary business expense, except that portion of dues payments related to representation on legislative issues. The IVMA estimates the portion attributable to legislative advocacy to be 15% in 2022. Contributions to the Indiana Animal Health Foundation are deductible as charitable contributions for federal income tax purposes to the extent provided by law.
